AMENDMENT № Fv-30-1067/20.02.2020 TO PUBLIC PROCUREMENT CONTRACT

1. THE EMBASSY OF THE REPUBLIC OF BULGARIA IN THE HELLENIC REPUBLIC IN ATHENS, BULSTAT /UIC/ national identification number: 099108624, address: Athens 15452, 33a Stratigou Kallari Street, Paleo Psychiko, represented by Valentin Poriazov, Ambassador Extraordinary and Plenipotentiary, hereinafter referred to as THE CONTRACTING AUTHORITY, on one side,

and

2. CLIMA ARISTOTEHNIKI E.E., national identification number: 997900142, having its main office at the following address in the city of Athens, Greece, assigned to performance of the contract: Antheon Street 56, Haïdari 12461, represented by Theodoros Remoundos, company manager, hereinafter referred to as **THE CONTRACTOR**, on the other side,

Being Parties to Contract № Fv-30-1067/23.12.2019 after a public procurement though collecting offers by virtue of Announcement № 55-18-135/12.11.2019 PPR ID №: 9094467/12.11.2019 and 9094795/25.11.2019 with subject: "Supply and installation of a new air conditioning unit for the Administrative Building of the Republic of Bulgaria in Greece, Athens" have signed the following amendment to the Contract.

Motivation for the signing of the Amendment:

In accordance with the requirements of the Law on Public Procurements, an alteration to the signed contract for assignment of public procurement according to Art. 116, par. 1, sub-paragraph 3 of the Law on Public Procurements is required; it refers to the time limit for the execution of the Contract for reasons and circumstances that do not depend on both contracting parties, namely: the obligatory procedure for issuance of clearance by the Ministry of Foreign Affairs of the Republic of Bulgaria to the Contractor in order to be granted access to the diplomatic mission of the Republic of Bulgaria in Athens has caused a delay in the execution of the contract.

The extension of the time limit does not affect the subject, nor the volume of the initially assigned works and does not lead to any changes in their final cost.

The parties have agreed to the following:

Art.1. Due to the circumstances explained in the above-mentioned Motivation of this agreement, both parties agree that the text of Article 4:

"The Contract enters into force on the date first written and on which the contract is signed by the parties and shall be valid for 60 calendar days from the date of signature thereof"

to be replaced by the following text:

" Article 4. The Contract enters into force on the date first written and on which the contract is signed by the parties and shall be valid for 140 calendar days from the date of signature thereof".

Art. 2. All remaining articles of Contract Nº Fv-30-1067/23.12.2019 signed with reference to the assignment of the public procurement with subject "Supply and installation of a new air conditioning unit for the administrative building of the Embassy of the Republic of Bulgaria in the Republic of Greece, Athens" remain unchanged.

This Amendment to the Contract was written and signed in two (2) identical copies – one for each of the contracting parties.
