ECONOMIC COMMITTEE

Meeting held at NATO Headquarters, 1110 Brussels, on Thursday, 12th February, 1976 at 10.15 a.m.

DECISION SHEET

I. EAST/WEST VISITS

The COMMITTEE:

- (1) noted the circulation by the Italian Representative of a contribution on the second session of the Joint Italian-Polish Commission (Warsaw, 15th and 16th January, 1976);
- (2) took note of the information provided by the French Representative.

II. REPERCUSSIONS OF TAXATION ON THE COST OF DEFENCE SPENDING OF MEMBER COUNTRIES

The COMMITTEE:

- (1) took note of the information supplied by the Economic Directorate, and agreed that this was an extremely complex question on which it would be advisable to have the views of national authorities and experts;
- (2) agreed that, if so requested by the Defence Review Committee, the Economic Committee would contribute to the study of this question;
- (3) invited the Economic Directorate to prepare a brief Note giving a broad idea of the readilyavailable information on taxation required by the International Staff;

III. COLLOQUIUM ON EAST/WEST TECHNOLOGICAL CO-OPERATION

The COMMITTEE:

- noted the circulation at the meeting of the Agenda for the Colloquium;
- (2) took note of a short statement by the Chairman on its organization.

IV. ASSESSMENT OF SITCEN NOTES

The COMMITTEE:

- (1) at the suggestion of the Chairman, held an exchange of views on the value of these Notes;
- (2) invited the Economic Directorate to continue circulating weekly lists of documents containing economic information.

V. TIMETABLE OF MEETINGS WITH EXPERTS

The COMMITTEE:

- (1) took note of the Political Committee's decision to hold a meeting with experts from capitals on 18th and 19th March to consider the implementation of the CSCE Final Act;
- (2) agreed to stand by its decision to hold, in the same week, a meeting with experts on the implementation of the provisions of the Final Act relating to Basket II (16th March was considered to be the most suitable date);
- (3) invited the Chairman, in agreement with the Chairman of the Political Committee, to co-ordinate the programme of work and dates of meetings of the two Committees and experts on this question;
- (4) took note of the following timetable for the next meetings with experts:
 - 26th February: economic trends in China;
 - 8th April: the energy situation in the Warsaw Pact countries;

- 13th and 14th May: population trends in the East European countries;
- 3rd June: economic trends in Bulgaria and Rumania;
- 10th and 11th June: Soviet defence expenditures;
- 1st July: the Soviet economy;
- (5) took note, in this connection, of a recommendation by the German Representative that the economic situation of the East European countries should be reviewed during the first half of each year, and agreed to return to this question at a future meeting.
