# DECISION SHEET

I. EAST-WEST VISITS

The COMMITTEE:

- was informed by the Turkish Representative of the visit to Bulgaria by the Turkish Foreign Minister, Mr. Caglayangil, on 10th and 11th September, 1977;
- (2) was briefed by the Greek Representative on the visit to Poland by the Greek Foreign Minister, Mr. Bitsios, from 29th August to 1st September, 1977.
- II. CSCE: EXCHANGE OF VIEWS ON CSCE IMPLEMENTATION (BASKET II) AND PREPARATIONS FOR THE BELGRADE MAIN MEETING
  - (a) Economic questions likely to be raised at Belgrade

The COMMITTEE:

- Made a preliminary examination of the draft report by the Chairman on the reinforced meeting of 8th September, 1977, circulated under reference ED/EC/77/71 on 15th September;
- (2) adopted an initial set of amendments which it invited the International Staff to incorporate in a revised version of the draft;
- (3) noted that, in view of the urgency of the matter (a Council meeting on the CSCE having been called for 28th September), delegations were invited to submit their comments and proposed amendments to the Economic Directorate in writing by not later than the evening of 20th September.
