Addendum to Working Paper AC/127-WP/575 dated 29th May, 1978

Note by the Acting Chairman

This paper supplements and updates AC/127-WP/575 by showing the trend in 1977 of officially-backed export credits granted by NATO countries to the Communist countries. Its contents will be incorporated in a revised version of the report once the latter has been re-examined by the Economic Committee on 14th September, 1978.

1. In 1977, officially-backed export credits(1) (commitments) granted by NATO countries(2) to the Communist countries totalled \$6.4 milliard, or a little less than in 1976 (\$7.0 milliard).

2. The Soviet Union and Poland were once again the main borrowers (\$2.4 and \$2.5 milliard respectively). However, loans to the Soviet Union were 30% below the 1976 figure, mainly because of the improvement in the Soviet balance of payments on current account, whereas credits for Poland rose again steeply (+37%). For the other East European countries borrowings were down 21% in the case of the GDR (\$0.5 milliard) and about the same as in 1976 for the other countries. At the same time, the credits extended to China (\$0.4 milliard) registered a sharp rise (see Table I).

3. The Soviet debt burden of \$12.4 milliard(3) increased at the same rate as in 1976, i.e. by 22%, whereas outstanding credits to the East European countries (\$11.0 milliard) rose faster than during the previous year (+43% as against 33%). The 55% increase, for the second year running, in the Polish debt burden (\$7.0 milliard)(3) deserves special mention. Outstanding credits to China (\$0.7 milliard) continued to fall (Table II).

4. The credits actually made available to the USSR by the NATO countries(4) (\$1.9 milliard) were slightly (9%) below those released in 1976. The Soviet Union remained the chief recipient of payments by members of the Alliance, closely followed by Poland, whose drawings of \$1.5 milliard were 65% up on the previous year. The cost of debt servicing(5) (principal plus interest) increased for all the European Communist countries, especially Poland where it more than doubled in the space of one year. And for Poland, the ratio of service payments to export earnings on Alliance markets rose sharply to 26% from the 1976 figure of 13% (see Tables IV and V).
