Subject: Implementation of the CSCE Final Act

As agreed at the meeting of the Political Committee on 23rd March, I enclose a draft questionnaire on Western implementation on the Human Contacts and Information provisions in Basket III of the Final Act, for consideration at the Political Committee's meeting on 8th April.

- 2. This draft questionnaire complements the draft questionnaire on Eastern implementation in POLADS(76)10 as revised by POLADS(76)12.
- 3. The attached questions on Human Contacts are fewer than those in the questionnaire in POLADS(76)10 and POLADS(76)12 for the following reasons: in many respects Western governments are already known to implement these provisions; and the questionnaire in POLADS(76)10 and POLADS(76)12 already contains a few key questions relevant to Western implementation, i.e. A(ii), B(ii), D and E(ii), (iv), (vii). The attached questions on Information, on the other hand, are almost identical to those on Eastern implementation in POLADS(76)10 and POLADS(76)12.
- 4. If the Political Committee decides in favour of such a questionnaire, it may be desirable to amalgamate it with the questionnaire in POLADS(76)10 and POLADS(76)12.
