**Decision of the Executive Director**  
**No 2013/09**  
**on the levels for security clearance for Frontex posts**  
**of 12 March 2013**

**THE DEPUTY EXECUTIVE DIRECTOR,**

Having regard to Decision of the Executive Director on the adoption of the Frontex Security Manual and the delegation of powers to the Deputy Executive Director in relation to the Security Manual of 17 March 2011, and in particular Article 2 thereof,

Whereas:

- 1) In accordance with the basic principles and minimum standards of security laid down in the Frontex Security Manual all persons who require access to information classified CONFIDENTIEL UE or above must be appropriately cleared before such access is authorised.
- 2) The Frontex Security Manual provides for a security clearance procedure for access to classified information.
- 3) Individual Members of Frontex staff may, by reason of their duties and for the requirements of the service, need to have knowledge of or use classified information.
- 4) The established level of security clearance for individual posts within Frontex should be reviewed.
- 5) The Deputy Executive Director is required to take the necessary implementing Decisions for the effective functioning of the Frontex security system.

**HAS DECIDED AS FOLLOWS:**

Article 1

Before taking up their position, future Frontex statutory staff must initiate the procedure for applying for security clearance required for their post in accordance with the Frontex Security Manual and this Decision.

Article 2

Before taking up their position, the employer must certify and provide a Personal Security Clearance Certificate (PSC) that the future Frontex SNE has the security clearance at the required level.

Article 3

All Frontex staff currently employed that do not have the security clearance at the required level must initiate the respective procedure immediately upon entering into force of this decision.

Article 4

The different levels of security clearance required for the posts in Frontex are listed in the Annex I to this decision.

Article 5

HR shall include the level of security clearance required for each open post in the respective vacancy notice. DED shall be consulted prior to that in case of new posts not included in this decision.

Article 6

The Decision enters into force on the day following its signature.
