The place of employment is Lisbon, Portugal.

#### **Functions and Duties:**

Under the responsibility of the Head of Unit B.3, 'Environment & Capacity Building' the successful candidate will be responsible for assisting in the activities of the Unit, and in particular shall be responsible for:

- Managing the day-to-day operation of the Equasis Management Unit, including regular contacts with data providers, Equasis users, the Technical Unit, etc.;
- Assessing all applications from data providers in accordance with the Data Providers Accreditation Procedure;
- Preparing an annual Equasis budget proposal for approval by the Supervisory Committee;
- Preparing documents for meetings, circulating papers and providing follow up to the Supervisory Committee and the Editorial Board meetings;
- Handling queries and complaints relating to the services provided through Equasis through a dedicated help desk;
- Preparing a detailed annual report of Equasis activities;
- Promoting Equasis through social media and maritime events.

### **Main skills and qualifications:**

- University degree or equivalent qualification or professional experience;
- At least 3 years of professional experience, in the area of the above-mentioned functions and duties, acquired after the award of the required qualification. When no university degree or equivalent qualification has been acquired, 7 years of experience is required, of which at least 3 must be in the area of the above-mentioned functions and duties;
- Excellent knowledge and proven usage of Equasis;
- Excellent knowledge of the roles and functions of stakeholders in the Equasis project (i.e. contributing parties, data providers, Supervisory Committee, Editorial Board, Management Unit, Technical Unit);
- Excellent level of written and spoken English with the ability to draft clear and concise texts;
- Proven experience in preparation and participation in meetings;
- Good knowledge and use of social media;
- Basic knowledge of operational aspects of IT systems;
- Proven experience and participation in international maritime forum or meetings is advantageous;
- Ability to communicate, both orally and in writing in French would be considered an asset.
