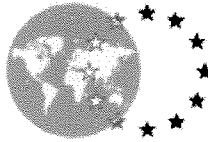

Applications will be examined by my services which will organise selection interviews during the course of February 2018.


