ACTION SHEET

I. RESPONSE TO THE WARSAW PACT'S NON-INCREASE OF FORCES PROPOSAL

The COMMITTEE:

- (1) had before it ISD/104 and proposed draft guidance circulated by the United States Delegation at the meeting;
- (2) continued its exchange of views on this subject in the course of which additional amendments were proposed to the United States draft and comments made thereon;
- (3) agreed to continue discussion at a meeting to be held on the morning of Wednesday, 29th January, immediately following the meeting of the Council.

II. MBFR AND AIR MANPOWER

The COMMITTEE:

- (1) noted that the views of the German Authorities on the new United States proposal continued to be as set out in their speaking notes of 16th January, 1975;
- (2) agreed to continue discussion of this subject at the meeting to be held on Thursday, 30th January.

III. DATA FOR USE WITH THE WARSAW PACT

The COMMITTEE:

in response to the Chairman's proposal of 16th January, 1975(1) agreed that each new revision of data could be transmitted to the

Ad Hoc Group for its internal use, except in cases where it was proposed that such data be used with the other side.

IV. INDEX OF GUIDANCE TRANSMITTED TO THE AD HOC GROUP

The COMMITTEE:

invited the International Secretariat to circulate a list indexing the guidance approved by the Council and transmitted to the Ad Hoc Group.

V. VISA REQUIREMENTS AS AFFECTING EAST EUROPEAN COUNTRIES

The COMMITTEE, in response to the enquiry by the Portuguese Representative at the meeting on 23rd January:

(1) noted the following information:

- there were no reciprocal visa requirements between Denmark and Romania and Bulgaria as a result of an initiative taken by the Danish Authorities;
- reciprocal visa requirements existed between the United States and all Warsaw Pact countries;

(2) noted the expression of gratitude made by the Portuguese Representative who indicated that his Authorities now had sufficient information to take a decision.
