- I. ANTI-WESTERN PROPAGANDA INCLUDING ACTIVITIES OF COMMUNIST "FRONT" ORGANIZATIONS
 - (a) Polish Communist Activities with Regard ... Africa
 The COMMITTEE:

took note of the German Delegation's note on this subject, AC/52-WP(63)14.

(b) Second Latin-American Youth Congress

The COMMITTEE:

heard a report by the Italian Representative about this Congress based on information emanating from the Italian Embassies in Cuba and Chile; this information confirmed Cuban announcements that the Congress would take place in Santiago de Chile on 6th to 11th August, 1963 and indicated that Cuban Communist and Trade Union leaders were energetically eliciting support for the Congress in Latin-America.

(c) Possible Meeting of the World Peace Council of Churches
The COMMITTEE:

was informed by the United Kingdom Representative that this Council was another name for the Christian Peace Conference; Archbishop Nicodim, although active in the World Peace Council, was note, as far as was known, a member of it.

(d) Departure of African Students from Bulgaria

The COMMITTEE:

- (1) heard on account from the German Representative of the treatment to which Togolese students leaving Bulgaria had been subjected in East Berlin;
- (2) had distributed to them by the United Kingdom Representative a reprint of an article by Robert Kotey entitled "Why We African Quit" which had been published in the London Observer; this article could be freely used provided that acknowledgement was made to the Observer.

II. CULTURAL RELATIONS OF NATO COUNTRIES WITH THE USSR AND THE EUROPEAN SATELITES

(a) Proposal for an Ad Hoc Study Group

The COMMITTEE:

- (1) had before them the Chairman's proposal AC/52-PSY/5 for the establishment of an Ad Hoc Study Group on Cultural Relations of NATO Countries with the USSR and the European Satellites;
- (2) noted that the Belgian, German, Greek, Turkish and United Kingdom authorities agreed on the principle of establishing such a Group;
- (3) noted that the United States authorities could not encourage the setting-up of such a NATO Group in view of the existance of an eight-nation Group on the same subject which would be meeting in Bonn early in May, 1963.
- (4) agreed to continue discussion of the Chairman's proposal at such a time as national delegations had been able to report detailed information on the origins, activities and terms of reference of the eight-nation Group.

(b) Danish Cultural 'preement with the Soviet Union

The COMMITTEE:

was informed that the cultural agreement negotiated between Denmark and the Soviet Union in 1962 had come into force on 25th February, 1963.
