SUB-COMMITTEE ON SOVIET ECONOMIC POLICY

DECISION SHEET

I. ECONOMIC REVIEW OF INDIVIDUAL EASTERN EUROPEAN COUNTRIES

(a) Bulgaria

The COMMITTEE:

- (1) approved, subject to confirmation by the United States Delegation, the text of the draft record of the special session on Bulgaria (AC/89-D/49), and instructed the Secretariat to circulate a consolidated version of it, modified in accordance with the amendments submitted by the United Kingdom and United States Delegations;
- (2) agreed to submit to the Committee of Economic Advisers their report on the Bulgarian economy (AC/89-WP/166)(1).

(b) Rumania

The COMMITTEE:

agreed to have an exchange of views on a note by the French Delegation on Rumanian economy in 1964 (AC/89-WP/167) at one of their future meetings.

II. ECONOMIC REVIEW OF EASTERN EUROPEAN COUNTRIES

The COMMITTEE:

- (1) noted a number of comments by the Belgian, French, German, United Kingdom and United States Representatives on the draft summary report on this subject prepared by the Economics Directorate (AC/89-WP/168);
- (2) agreed to resume discussion at their next meeting on the basis of a revised version of the above-mentioned document.

III. PRICES AND STRUCTURE OF SOVIET FOREIGN TRADE

The COMMITTEE:

- (1) noted the Chairman's request to all interested delegations to obtain their authorities' views on the conclusions recorded in paragraph 7 of working paper AC/89-WP/153/2 by the German Delegation;
- (2) were informed by the United States Representative that he would shortly circulate comments on this item.

IV. 1964 GRAIN HARVEST IN COMMUNIST COUNTRIES

The COMMITTEE:

- (1) had a final exchange of views on the question of the 1964 grain harvest in Communist countries;
- (2) heard a preliminary estimate by the United States Representative of the 1965 grain harvest in the USSR and of grain imports by Communist countries during the agricultural year 1965/66;
- (3) agreed to put on the agenda of their next meeting the problem raised under (2).

V. ECONOMIC DEVELOPMENTS IN COMMUNIST CHINA IN 1964

The COMMITTEE:

- (1) were informed by the Netherlands Representative that he would shortly circulate his authorities' comments on AC/89-WP/161(1);
- (2) agreed to resume this discussion upon receipt of comments to be submitted by the United States Delegation.
