I. APPROVAL OF DECISION SHEETS OF PREVIOUS MEETINGS

The COMMITTEE:

II. <u>EAST-WEST VISITS</u>

The COMMITTEE was briefed:

- by the Turkish Representative on the economic aspects of the visit to Bulgaria of Mr. S. Demirel, Prime Minister of Turkey from 1st to 3rd December, 1975;
- (2) by the Greek Representative on the results of the visit to Athens from 10th to 14th November last of the Bulgarian Minister for Trade on the occasion of the 4th Interministerial Session of the Joint Commission for Greco-Bulgaria Co-operation;
- (3) by the Norwegian Representative on the results of the first session of the Joint Commission for Economic, Industrial and Technical Co-operation between Norway and the GDR, held in Oslo from 15th to 27th November, 1975.

IV. EFFECTS OF PRICE CHANGES ON DEFENCE EXPENDITURES OF NATO MEMBER COUNTRIES

The COMMITTEE:

- approved the document as revised subject to minor amendments to paragraph 11;
- (2) noted a statement by the Canadian
 Representative pointing to the difficulties
 of the work undertaken thus far but agreeing
 that it was important to continue with it;
- (3) agreed to forward the document to the Council with a cover note from the Chairman elaborating on the Committee's recommendation that the exercise should be continued in view of its value in appraising the defence effort of member countries.

V. RECENT ECONOMIC DEVELOPMENTS IN EASTERN EUROPE AND INTRA-COMECON RELATIONS

- (1) noted the minor amendments proposed by members of the Political Committee circulated in a corrigendum dated 17th December;
- (2) noted comments made by several representatives, including in particular the remarks of the Belgian Representative, on the additions to paragraph 15;

- (4)expressed the hope that the final version of the document would be placed on the Agenda of a Council meeting in January.

The COMMITTEE:

- noted the latest information from the Chairman on contributions either already received or expected from delegations for the above-mentioned meeting;
- (2)noted that the International Staff would be circulating early in January a working schedule to guide the experts' discussions.

VII. EXCHANGE OF INFORMATION

The COMMITTEE:

- (1)noted a table from the Economic Directorate circulated during the meeting and showing the economic growth of the USSR by sectors in 1975 and 1976 and likewise noted that a preliminary note on the new Soviet Five-Year-Plan would be circulated shortly;
- (2) noted the circulation to the meeting by the United States Representative of three contributions on prices in Hungary on industrial development in Romania and on the probable expansion of economic relations between North Vietnam and the COMECON:
- noted a Canadian contribution on the seventh Polish Workers Party Congress (8th December. 1976).
