I. DEMOGRAPHY IN THE SOVIET UNION AND EASTERN EUROPE

The COMMITTEE:

- after approving the programme of work set out in AC/127-A/506, heard and discussed statements by the United States, German and French Experts and the Italian Representative;
- (2) took note of the distribution during the meeting of additional contributions by:

the United States Delegation (manpower and population policies and trends in the USSR);

the German Delegation (population trends in Bulgaria);

the French Delegation (analysis of population trends in Rumania);

(3) also noted the distribution, by the International Staff, of tables, graphs and press cuttings to facilitate a comparative evaluation of overall population trends in the Alliance countries and the Warsaw Pact countries and took note of the Chairman's introductory speech on this subject;

(4) invited the International Staff to prepare, on the basis of contributions from delegations and in the light of the discussions, a draft consolidated report which, subject to prior approval by the experts and national representatives, could be forwarded to the Council for information.

#### II. SCHEDULE OF MEETINGS

The COMMITTEE:

- noted that, as an exception, the next ordinary meeting would take place on <u>Tuesday</u>, <u>lst June</u>, <u>1976 at 3 p.m.</u>;
- (2) noted that the United Kingdom Delegation would like the Agenda for the meeting on the defence expenditure of the Soviet Union to be prepared and distributed sufficiently in advance;
- (3) accepted the United States Representative's suggestion to reverse the dates of the meetings on the economic situation in the USSR (lst July) and on three East European countries: Poland, the GDR and Czechoslovakia (8th-9th July) (subject to confirmation by the German Representative(1)).
