DECISION SHEET

I. EXCHANGE OF VIEWS ON THE IMPLEMENTATION OF THE FINAL ACT OF THE CSCE AND PREPARATION OF THE 1977 BELGRADE MEETINGS (BASKET TWO)

The COMMITTEE:

- (1) noted that the United Kingdom Delegation would be informing it of the outcome of the work of the Working Group of the "Nine" on the CSCE (meetings on 3rd, 4th and llth February) particularly with respect to the possible submission by the Community countries in Belgrade of new proposals within the framework of Basket Two;
- (2) noted, furthermore, a statement by the Netherlands Representative outlining his Authorities' preliminary views on the suggestions contained in the United States Delegation's note dated 20th January; noted, in particular, that these views formulated prior to the meeting of the "Nine" on the CSCE did not reflect the official Netherlands position and were simply an initial contribution to the Committee's discussion of the United States proposals;
- (3) likewise noted the German Authorities' initial reaction to these proposals, currently the subject of a detailed study in Bonn the outcome of which would be reported to the Committee by the German Representative in due course;
- (4) agreed to continue this discussion at its next meeting.

The COMMITTEE:

- (1) noted a statement by the French Representative conveying his Authorities' views on the general problem of declassification of NATO documents and their reservations concerning the declassification of Economic Committee papers (except when otherwise decided by Council); the French Authorities believed that the Committee must remain first and foremost a forum for the exchange of information drawn from special or privileged sources (particularly where the economies of the Eastern countries were concerned);
- (2) noted furthermore, as regards draft ED/EC/77/2 that comments would be submitted by the French Representative when this paper came before the Council;
- (1) ED/EC/77/10(Revised), distributed on 2nd February, 1977

- (3) on the initiative of the Netherlands Representative, had a general exchange of views on this matter and noted the Chairman's reminder of the guidelines laid down by the Council for the declassification of the report on Soviet defence spending; noted the views expressed by the Netherlands and the German Representatives, in that order, who were in favour of more declassification while remaining conscious of the particular problems which this could post for individual countries;
- (4) noted in this connection that the United States and German Representatives could agree to the three unclassified versions proposed at reference above whereas the Canadian Representative wished to have further time in order to obtain his Authorities' views on this matter;
- (5) agreed that unless objections were received by the International Staff before the next meeting, the unclassified version of the report on defence spending would be regarded as approved by the Committee (subject to the amendments adopted at the previous meeting) and forwarded to the Council in compliance with paragraph 72 of C-R(76)47.
- IV. APPRECIATION OF THE ECONOMIC POSITION OF THE NATO AND THE WARSAW PACT COUNTRIES UP TO 1984

At the request of a number of delegations which had not yet received their instructions, the COMMITTEE:

- (1) agreed to defer discussion of the reference documents until the next meeting;

noted the distribution of a paper from the Canadian Delegation (based on a report from the Canadian Embassy's trade section in Vienna) on the continuing difficulty of obtaining access to post-CSCE Bulgarian trade statistics.
